NOTICE OF SUSPENSION WITH CONDITIONS
(By Consent)

Notice Issued: October 9, 2014

Daniel Noveck, P 28087, Bingham Farms, Michigan, by the Attorney Discipline Board Tri-County Hearing Panel #51.

1. Suspension - 270 Days
2. Effective March 7, 2014

On March 7, 2014, the Grievance Administrator filed a Motion for Order to Show Cause Why Discipline Should Not Be Increased, stating that respondent continued to practice law while serving a 90-day suspension issued in *Grievance Administrator v Daniel Noveck*, Case No. 13-30-RD.

On May 19, 2014, respondent and the Grievance Administrator filed a stipulation for a consent order of discipline, in accordance with MCR 9.115(F)(5), which was approved by the Attorney Grievance Commission and accepted by the hearing panel. Based on respondent's acknowledgment, the hearing panel found that respondent practiced law while still suspended, in violation of MCR 9.119(D) and (E).

In accordance with the stipulation of the parties, the hearing panel ordered that respondent's suspension from the practice of law be increased to a 270-day suspension, effective March 7, 2014, the date the Grievance Administrator filed the motion to increase discipline, and that respondent shall continue to be subject to the conditions which were ordered in *Grievance Administrator v Daniel Noveck*, Case No. 13-30-RD. Costs were assessed in the amount of \$750.00.
