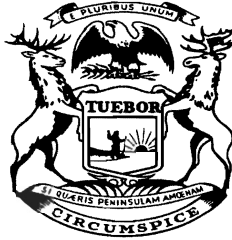

NOTICE OF REPRIMAND AND RESTITUTION
(By Consent)

Case No. 13-83-GA

Notice Issued: January 15, 2014

Saun-Roland Scott, P 57168, Detroit, Michigan, by the Attorney Discipline Board Tri-County Hearing Panel #27.

1. Reprimand
2. Effective December 27, 2013

The respondent and the Grievance Administrator filed a stipulation for a consent order of discipline, in accordance with MCR 9.115(F)(5), which was approved by the Attorney Grievance Commission and accepted by the hearing panel. Respondent pled no contest to the allegations that he neglected a legal matter, in violation of MRPC 1.1(c); failed to seek the lawful objectives of his client, in violation of MRPC 1.2(a); failed to act with reasonable diligence and promptness, in violation of MRPC 1.3; failed to keep his client reasonably informed of the status of a matter, in violation of MRPC 1.4(a); failed to explain a matter to a client to the extent necessary to permit the client to make informed decisions regarding the representation, in violation of MRPC 1.4(b); failed to refund the unearned portion of an advance fee, in violation of MRPC 1.16(d); and failed to notify the client, in writing, by registered or certified mail, of his suspension, in violation of MCR 9.119(A). The panel also found that respondent violated MRPC 8.4(a) and (c); and MCR 9.104(1)-(4).

Based on the stipulation of the parties, the hearing panel ordered that respondent be reprimanded and pay restitution in the amount of \$240.00. Costs were assessed in the amount of \$881.97.
