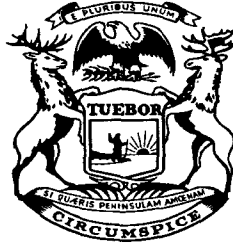

NOTICE OF SUSPENSION AND PROBATION
(By Consent)

Notice Issued: August 10, 2007

Paul W. Sawyer, P 53077, Mt. Clemens, Michigan, by the Attorney Discipline Board Tri-County Hearing Panel #101.

1. Suspension - 180 Days
2. Effective October 5, 2006¹


and

3. Probation - 2 Years
4. Effective August 9, 2007

Respondent was convicted September 12, 2006 in the Macomb County Circuit Court, Mt. Clemens, Michigan for operating intoxicated/impaired/controlled substance-3rd, in violation of MCL 257.6256D, a felony. In accordance with MCR 9.120(B)(1), respondent's license to practice law in Michigan was automatically suspended on the date of the felony conviction.

The respondent and Grievance Administrator filed a stipulation for consent order of discipline, in accordance with MCR 9.115(F)(5), containing respondent's admission to the conviction. Based on that admission, respondent was charged with a violation of MCR 9.104(A)(5).

In accordance with the stipulation approved by the Attorney Grievance Commission, the panel ordered that respondent's license to practice law in Michigan should be suspended for 180 days, effective October 5, 2006, to run concurrently with the suspension ordered in Grievance Administrator v Paul W. Sawyer, Case Nos. 05-69-GA; 06-64-GA; 06-65-JC. The panel also ordered that respondent be subject to a two year probation, effective August 9, 2007, and assessed costs in the amount of \$759.28.
