Respondent was convicted of operating under the influence causing serious bodily injury, a felony, in violation of MCL 257.6256D, in a matter titled *People of the State of Michigan v Dennis Klimek*, Macomb County Circuit Court, Case No. 2018-002281-FH. In accordance with MCR 9.120(B)(1), respondent's license to practice law in Michigan was automatically suspended effective January 23, 2019, the date of respondent's felony conviction.
