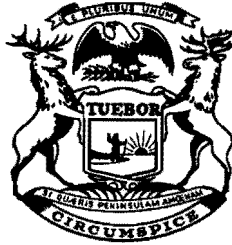

**NOTICE OF DISBARMENT**

**Notice Issued: October 17, 2019**

Jarod M. Calkins, P 64661, Carleton, Michigan, by the Attorney Discipline Board Tri-County Hearing Panel #5.

Disbarment, Effective September 5, 2018.<sup>1</sup>

Respondent was convicted, by guilty plea, of four counts of felony misconduct in office, in violation of MCL 750.505, in a matter titled *People of the State of Michigan v Jarod M. Calkins*, 38th Circuit Court Case No. 18-244382-FH. In accordance with MCR 9.120(B)(1), respondent's license to practice law in Michigan was automatically suspended effective September 5, 2018, the date of respondent's felony convictions. Based on respondent's convictions, the panel found that he engaged in conduct that violated a criminal law of a state or of the United States, in violation of MCR 9.104(5).

The panel ordered that respondent be disbarred from the practice of law in Michigan. Total costs were assessed in the amount of \$2,896.69.
