The Respondent, represented by counsel, entered into a Stipulation for Consent Order with the Grievance Administrator in disciplinary proceedings involving two (2) Formal Complaints consolidated for hearing. By the terms of that Stipulation, the Respondent admitted all of the allegations contained in those Complaints, to wit: that Respondent was retained in December 1983 to file a Petition for Rehearing in a matter before the Michigan Employment Security Commission but that he failed to take appropriate action to further the legal interests of his client and failed to communicate with her; that Respondent failed to file a timely Answer to a Request for Investigation and failed to respond to the Grievance Administrator's further attempts to obtain a full and fair disclosure of the circumstances described in that Request for Investigation; and that the Respondent failed to Answer a Formal Complaint filed and served by the Grievance Administrator in October 1985. The Respondent admitted that his conduct described in those Complaints constituted violations of MCR 9.104(A)(1-4)(7) and Canons 1,6, & 7 of the Code of Professional Responsibility, DR 1-102(A)(5-6); DR 6-101(A)(1-3) and DR 7-101(A)(1-3).

In accordance with the specific terms contained in the Stipulation filed by the parties, the Hearing Panel entered an Order placing the Respondent on probation for a period of two (2) years subject to conditions which include the filing of written quarterly reports concerning the supervision of his law practice by another attorney and the progress of continuing medical treatment. Upon a showing by the Grievance Administrator that the Respondent has committed professional misconduct during the period of probation, the Order of Probation will be vacated and a One Year Suspension will be imposed in addition to any other discipline imposed as the result of the subsequent misconduct. Costs were assessed in the amount of \$112.15.
